

1. Instructions, prizes and information on how to enter form part of these conditions of entry. By entering, entrants accept these conditions of entry.

3. The promotional period begins at 9.00 am 3rd March 2026 and ends at 11:59 pm, 25th March 2026 (**Promotional Period**).
4. Entries are open to all registered club cricketers in New Zealand who are 18 or older, excluding employees of New Zealand Cricket, their immediate families or any agents including other advertising, marketing or promotional firms associated with this competition.

Entry

10. NZC will select 6 entrants to compete at the WHITE FERNS / BLACKCAPS double header at Eden Park on 20 March 2026. NZC's selection of the 6 finalists shall be at its sole discretion.
11. The Finalists shall be notified by NZC by phone or by email. If a selected Finalist cannot be contacted after reasonable attempts or if they cannot attend Eden Park on 20 March 2026, NZC reserves the right to select a replacement Finalist or run the Competition with fewer than 6 Finalists.
12. All Finalists shall be provided with 4 GA tickets to attend the WHITE FERNS / BLACKCAPS double header on 20 March 2026.
13. Each Finalist shall be responsible for all travel arrangements and expenses in relation to attending the match and taking part in the Competition.

18. A Finalist must catch a ball in each round to progress to the next round. In the event that a Finalist does not catch a ball in a round they shall be eliminated.
19. If at the end of the 3 rounds, the remaining Finalists shall compete in a knock-out format until there is only one Finalist remaining.

Prizes

20. The winner of Competition will receive the Major Prize.
21. All other Finalists will receive one Minor Prize each.
